# **Meeting Minutes**

October 10, 2023

Forsyth Library Room #217 and ZOOM - 1:30 pm

- 1) President Nicole Frank called the meeting to order at 1:32 pm.
- 2) Roll call of Members
  - Per the attached Roll Call Register
- 3) Approval of August and September minutes:
  - A motion was made by Susan Relaford and seconded by Kerri Schiffelbein to approve the August 8<sup>th</sup> meeting minutes. The motion was carried.
  - A motion was made by Misty Koonse and seconded by Raeleann Weigel to approve the September 12<sup>th</sup> meeting minutes. The motion was carried.
- 4) Guests: There were over 50 guests in attendance. Guest attendance can be seen on the Roll Call Register. Guests were largely there to ask VP of Administration and Finance Wesley Wintch questions about the new Power Plant wage increase.
  - A one question/one answer protocol was enforced, to allow time for all who wanted to ask questions to do so.
  - Attendees asked questions on wages, work study and pay jump for the Power Plant workers.
  - VP Wesley Wintch shared the frustrations that led to the Power Plant wage increase Power Plant has big boilers, and keeps campus heated all winter long. The Power Plant has to be staffed 24/7 during the winter, requiring 5 boiler operators. Last Spring two boiler operators left, the job was posted and after two months no one had applied. The wage was raised and the reach for the position posting was increased, to no avail. The most recent increase was a market correction for the whole department. Senators and guests responded to VP Wintch's explanation:
    - i) Other employees do not feel they are not making what they should be.
    - ii) Other areas on campus that haven't received applications for open positions, but no effort has been made to raise the wage for those positions.
    - iii) Staff are feeling not important right now and feel like they just get tossed to the side.
    - iv) Staff are constantly asked to "team play" when times are lean, and we are losing a lot of young people.

### Cabinet highlights:

- Workflex was approved. Staff Senate contributions here include 1) asking that "without notice" be replaced with "with notice" in the policy language and "ongoing" be added to descriptions of Alternate Work Schedule and Compressed Work Schedule, for consistency and clarity, and that 2) "Does not require a Remote Work Suitability Form" be added to the description of Temporary/Emergency Remote Work Arrangement, for clarity.
- Dennis King reported enrollment numbers: Headcount down 108 total: -41 oncampus, -72 online, +5 international partnerships, -1.5% SCH overall.
- o The catering/food service RFP should open by the end of October.
- The legislature cut the budget request from \$570m to \$301m. From KBOR, the budget requests go to the governor, then on to the legislature, so things could change considerably over the course of this process. Nothing is official until April or May 2024. Be mindful of how a reduction in property taxes (being discussed by legislature) affects FHSU Educational Building Fund monies. FHSU gets \$1m in these monies, which must be used on repairs of buildings.

- Staff Senate Committees (chair in bold)
  - i) Goals Committee (Les Mackey, Hannah Hearld, Tyler Marcotte, Brett Gerber, Marnie Kohl, Misty Koonse) talked about what they would like to see after the first Staff member awards.
  - ii) Recognition Committee (*Hannah Hearld*, Susan Relaford, Tyler Marcotte, Tobi Neuberger, Falynn Rogers, Amy Richecky) Meeting October 13<sup>th</sup>, to select recipient for the November Staff Member of the Month Award.

- iii) Events/Promotion Committee (*Misty Koonse*, *Staci Kinderknecht*, *Marnie Kohl*, *Ali Colwell*) The first Staff Social was held on September 21<sup>st</sup> and hosted by OSSP/ the Grad School and it went well. The next one will be held December 19<sup>th</sup> from 1:30 to 3pm in the Union. The committee is looking for volunteers to help judge the holiday door decorating contest.
- iv) Scholarship Committee (*Diana Staab*, *Tobi Neuberger*, *Raeleann Weigel*, *Kerri Schiffelbein*, *Tyler Marcotte*) Will not meet until after the fall semester.

### KBOR Groups/Committees

i) UPS Council/USSC Joint Meeting (Nicole Frank, Les Mackey, Marnie Kohl) – This group met on October 3<sup>rd</sup>. Representatives discussed their respective conversations with their administrations about holiday shutdown plans. Layoff "bumping" policies which allow for someone who is terminated from one position to instead be demoted or moved laterally to another position, effectively bumping a lower-seniority employee from their position, and staff professional development days, such as KU's Staff Leadership Summit.

# University Committees

- i) Library (Lacey Wegner) Have not met
- ii) Staff Development (Bob Duffy, Kerri Schiffelbein) The committee reviewed three years' worth of staff development fund transactions, to consider whether the cap allowed each staff member could be sustainably increased. Staff are limited to \$500/year, whereas adjunct faculty are eligible for \$800 if attending/participating and up to \$1000 if presenting. Full-time faculty are eligible for \$1500/\$1700, with an additional \$500 provided for international professional development. The committee decided to bump up to \$800 or \$1000 if presenting. We are not sure when this will go into effect.
