AGREEMENT TO ENROLL IN INTENSIVE ENGLISH LANGUAGE STUDY

English Language Proficiency

FHSU requires all non-native speakers of English to fulfill the English Language proficiency as part of the admission requirements. All international students must meet minimum English proficiency requirements before beginning coursework at Fort Hays State University. Persons pursuing undergraduate or graduate admission must submit an official language test score from one of the following standardized tests.

The exemptions for the English Language requirement will be granted if :

- 1. you graduate from a US high school,
- 2. you graduate from a US college or University with an associate's, bachelor's, master's, or doctoral degree, or
- 3. successfully complete a language program at any one of the approved FHSU language institutes *

English Language Proficiency is determined by one of the following standardized test score

If you have already satisfied this requirement and can provide an **official copy** of your language score, this page does not apply to you and you need not return it with your application materials. However, if you have not taken a language proficiency test, or if your language proficiency test score falls below the minimum requirements, your application to FHSU will not be completed until you have submitted this agreement.

You will not be permitted to begin coursework at FHSU without the required language score. However, you may be admitted to the university and given the I-20 if:

- 1. You meet all other requirements for admission.
- You agree to enroll in the Intensive English program on the FHSU campus until either the
 required language score is met or upon completion of the Intensive English program, at which
 time you will be allowed to begin FHSU coursework toward your degree.

Fort Hays State University's regular academic programs of study begin only during the months of August, January and June.

Conditional admission will be offered if students have the acceptable academic credentials & financial support but have not met the English Proficiency Required Score. Students may be conditionally admitted if they have a TOEFL score of 460-499 on the paper based or 140-170 on the computer based exam or 48 on internet based exam OR a score of 66 on the Michigan (MELAB). Students will be required to take the FHSU Intensive English Program and successfully complete the 12 hours of coursework with a "C" average or better in each class. Successful completion of this language program only applies to FHSU's basic language proficiency requirement and may not be considered successful language proficiency at any other college or university. In addition to successful completion of the 12 hours, the student will need to have a passing score on any one of the above standardized tests BEFORE they graduate with a degree from FHSU. Please read the letter of admission thoroughly and follow the detail on what condition you must pursue to meet the regular admission status.

Based on review of the students application materials and current language proficiency it will be determined whether students are eligible for:

- 1. full time enrollment in University classes, or
- 2. a combination of both academic & English classes ENG 100/103, or ENG 121 depending on the recommendation from English Dept. Undergraduate students will get credits for all English classes toward the BA degree if earned the passing grade of B or better.

<u>PLEASE NOTE</u>: Enrollment based on **conditional admission** in the 12 hour Intensive English Program is **NOT** negotiable.
