As we approach midsemester, it's important to ensure you're on track academically. Take a moment to familiarize yourself with your academic advisor and schedule a meeting to discuss your course selections for the upcoming Fall 2024 semester or summer term. If you're considering online courses, there are specific requirements you need to be aware of. Undergraduates should be registered in I2 hours of on campus classes, while graduate students should have 9 hours. Keep in mind that only 3 hours of online coursework count towards full-time enrollment according to SEVIS regulations. If you have questions about this, please visit the International Office for assistance.

Additionally, don't forget to check your mid-term grades around March II in Workday. This will give you valuable insight into your academic progress. If you find yourself facing challenges, remember that FHSU has resources to support you. Feel free to reach out, and we'll connect you with the resources you need to succeed on campus.

IMPORTANT REMINDERS

Homeland Security officers may conduct surprise campus visits to verify students' personal information, including addresses and phone numbers listed in the SEVIS record. It's crucial to keep your information updated in Workday to ensure compliance.

As an international student, it's crucial to prioritize your studies over on campus work commitments. Regulations permit you to work a maximum of 20 hours per week during the academic term. It's important to note that working off-campus is strictly prohibited unless you have obtained OPT or CPT authorization. Violating this rule can result in consequences, including fines for the employer and potential deportation for you, jeopardizing your student status and future in the U.S. Remember, your visa is for studying, not for work purposes. For inquiries or concerns, reach out to the International Office for assistance. Stay compliant and focused on your academic journey.

Daylight Saving Time in the United States is observed by most of the United States. This year, daylight savings time is on Sunday, March IO at 2:00am in the morning. You will want to set your clocks ahead I hour.

SCHOLARSHIP OPPORTUNITIES

The Stouffer International, Solko & Olliff Family International Student, and Graduate Student Rotary International are scholarship opportunities students can apply to for the 2024-2025 academic year.

Students must be a currently enrolled on campus FHSU student with at least one full year of course work to be eligible.

This is also a good time to visit with your academic advisor about the rest of the semester and plan for the fall 2024 semester.



REQUEST FOR INVITATION LETTERS

As you approach graduation, if your family plans to attend the ceremony in May, our office staff is ready to help by providing invitation letter(s) upon request. While these letters are not mandatory for visa applications, we are pleased to create them for each family member attending. Just reach out to us via email at ISSS@fhsu.edu or visit our office in the Memorial Union 014 to request the invitation letter request form. Once you have completed the form, return it to us and allow 48-72 hours for processing. You will be notified once the letter(s) are ready. We look forward to sharing this special occasion with you and your family!



HAVE YOU CHECKED YOUR PASSPORT & I-20?

If your passport or I-20 is nearing expiration, it is essential to obtain updated documents, even if you have no immediate plans to travel outside of the United States. If your I-20 is set to expire in May and you will not be graduating, a completed Program Extension form and updated financial statement must be submitted to the office. Contact our office if you have questions or need assistance. It is crucial to maintain current I-20 and passport to ensure compliance with immigration regulations."

SPRINTAX & INCOME TAX RETURN

Remember to be preparing and attending workshops regarding completing your US income tax return. If you have not received your W2 tax form, reach out to Marnie.

If you did not work or earn income in the US, you are still required to file Form 8843 with the IRS if you were in the US during 2023.

FHSU provides FREE access to Sprintax Tax Preparation, which will assist you in preparing and filing your taxes. Be watching for the FREE access code for the Federal filing and instructions and remember, DO NOT complete Sprintax tax filing until you receive the code and ALL tax forms (W2, I042-S, I099s, etc.). You will need to pay for the State filing after the review section in Sprintax. Keep your tax documents safe until then.

Working sessions have been scheduled for this month to provide students with dedicated time to work on the Sprintax filing with Marnie being available to help with questions. You must attend these working sessions if you want assistance. You can attend as many of these as you need. Make sure you read emails regarding taxes.
