



# GMAT Fee Waiver Application

The FHSU MBA program has a limited number of GMAT fee waivers available each academic year to help economically disadvantaged students and FHSU alumni interested in pursuing a MBA at FHSU. If approved, the fee waiver can be used for one test administration. Students are not eligible for multiple fee waiver awards.

Students must have applied for admission to the FHSU MBA program and have official transcripts on file in the FHSU Graduate School at the time of selection.

## Eligibility:

- Must be a U.S. citizen or permanent resident
- Must be in good academic standing (if a current student) or good academic standing at the time of graduation
- Consideration is given to, but is not limited to, students from the following groups:
  - FHSU undergraduate students or alumni
  - Displaced workers
  - Under-employed college graduates
  - Active military personnel or their spouses
  - Military veterans

The FHSU MBA Committee will review completed fee waiver applications, including the application, resume, and unofficial transcripts. **The deadline to apply for a GMAT fee waiver at FHSU is April 1.** Students selected will be notified with instructions on how to register for the GMAT using a fee waiver by May 1. The student must have their fee waiver information at the time their exam appointment is scheduled.

A student selected for a waiver is not guaranteed admission in the FHSU MBA program.
