KANSAS NOTARY PROCEDURES

- 1. Fill out the Kansas Notary Bond Request form, including the department name with the business address of 600 Park Street, Hays, KS 67601.
- 2. Send the completed Kansas Notary Bond Request form to Cheryl Kelley at Gallagher by fax 512-652-2462 or email (cheryl-kelley@ajg.com).

NOTE: Gallagher is required by law to wait 30 days from the expiration date to process the renewal of a notary appointment. Please send the request form to Gallagher approximately 45 days prior to the anniversary date so Gallagher can begin the renewal process 30 days prior.

- 3. Cheryl Kelley at Gallagher will complete the Kansas Public Appointment Form with the information provided from the Kansas Notary Bond Request form, including sections A and C (Notary Surety Bond).
- 4. The Notary Public Appointment Form will be sent to the requestor's email or home address to sign, seal, and have their signature notarized. Gallagher will have Sections A and C filled out from the information provided on the request form. The applicant will need to provide their notary stamp/seal in Section A, #7. The notary's signature must be notarized in Section B.

The completed Notary Public Appointment Form, along with a copy of the Notary Public Errors and Omissions Policy bond (currently Travelers Casualty and Surety Company of America) will need to be delivered to the Business Office; and a Workflow Interfund Request Form filled out to pay for the **\$25.00** filing fee to the KS Secretary of State. Type the following information in the comments section of the Interfund Request Form:

The department will hand carry the Notary Public Appointment Form to Accounts Payable and put a note on the form to RUSH the \$25.00 filing fee. Please note the Interfund number when dropping off this form. Accounts Payable will process the Interfund and mail the form to the Kansas Secretary of State Office. The Secretary of State's office will process the request typically on the same day it's received and mail the booklet and certificate license to the person's home address.

5. Gallagher will send an invoice to the department. Gallagher does not accept credit cards, so the department must process a Workday Supplier Invoice for the \$50.00 payment:
