




Q1. How important is the issue of smoking on campus to you?



Q3. Please indicate your level of agreement with the following statement: -I find that people smoking at the entrances to campus buildings is a problem.




Q4. Please indicate the extent to which you consider each of the following a problem: - Second hand smoke








Q6. Please indicate the extent to which you consider each of the following a problem: - Smoking in close proximity to buildings

That would cause issues with being on time especially, as well as several other problems for smokers and non-smokers alike.

Overall, I think smoking greatly effects both smokers' and nonsmokers' health and well-being. Perhaps in addition to a complete smoking ban on campus, FHSU should refer students to the Kelly Center for help quitting as well as offer other referrals/resources for smokers.
