Edmund Shearer Faculty Advisor of the Year

•Dr. Griffin recognized Dianna Koerner for receiving the Edmund Shearer Faculty Advisor of the Year Award.

TigerConnect

•Dr. Griffin introduced TigerConnect to the Committee

°TigerConnect is a social networking site, much like Facebook, but geared toward higher education for first-time students. This first year, the university is going through the learning process and working with other schools that have been very successful, utilizing it as part of first year experiences and retention purposes. The university is creating support for students in a social sense, academic sense, and personal sense to giving them needed resources. Students started with TigerConnect in April of this year. Currently, the students who are using TigerConnect or have been invited to join are all new on-campus students. Dr. Griffin will confirm that new first-time virtual students are loaded into TigerConnect. Discussion was held to possibly include information about TigerConnect in letters from the Registrar's office to students who are admitted as first-time freshman or re-entry students.

°TigerConnect will provide a variety of alerts to different areas on-campus within student support services. When logging onto TigerConnect, a student is prompted to answer a question. Alerts are generated and forwarded to support services to address student issues. Departments will be able to connect with students using this format of information.
