3. TEXTBOOK AND COURSE MATERIALS

No Required Textbooks.

This course requires you to have regular access to a camera or equivalent work. Acceptable cameras are DSLR (Digital Single Lens Reflex), mirrorless, 35mm, other analog cameras, or as appropriate to your artwork. Alternative photographic processes can be used in place of lens-based work.

4. COURSE DESCRIPTION

This is an advanced level course focusing on research and experimentation in the medium of photography. Each student will be required to self-examine their skills and interests to then develop their practice. Regular meetings with the professor for consultation and development in technical and conceptual progress will be needed. Research and development on interests and making comparisons and distinctions made to other artists and movements will also be necessary.

5. COURSE OBJECTIVES

- Develop a personal practice in researching contemporary and historical artists and groups related to student's content
- Articulate and discuss formal and conceptual aspects of personal work, as well as classmates work in critiques and discussions
- Strengthen content of work through experimentation and exploration of the medium
- Discuss conceptual ideas and apply critical thinking to readings and research



6. TEACHING, LEARNING METHODS, & COURSE STRUCTURE

Teaching will be active discussions exploring personal artwork. Learning will come from discussions, readings, research, and most importantly through the creation of artwork. The more production that is done, the more beneficial it will be for the student. Individuals will need to determine goals and work output needed for the semester.

Average expectations of collegiate study are two to three credit hours spent per credit hour of a course, which means six credit hours <u>outside of class time</u> for a three-credit course. Emphasizing that is for **average**, **typical**, **mediocre**, **or ordinary** students, and that is for all studies at a college.

Use of a notebook and other materials is vital to keep organized, meet deadlines, and to not fall behind.
