# **Fall 2024 Application for Student Teaching Information**

This information is intended for candidates who will be eligible to student teach during the fall 2024 semester. If you aren't sure when you'll be eligible to student teach, please reach out to your advisor(s) for confirmation.

### STUDENT TEACHING ADMISSION REQUIREMENTS:

#### APPLICATION AVAILABILITY, DEADLINE, AND REVIEW:

- The Fall 2024 Application for Student Teaching will be available from January 1<sup>st</sup> through February 15<sup>th</sup>.
- ➤ The deadline for application submission is 11:55 PM (CST) on February 15<sup>th</sup>.
- Late applications will not be accepted.
- ➤ Please allow 4-6 weeks for application processing. Once your application has been reviewed, you will receive a notification and information relating to any deficiencies you might have.

### **APPLICATION PROCESS**

The Office of Field Experiences & Licensure has implemented a program called **Sonia** to manage student information and field experience placements. To apply for Fall 2024 Student Teaching, you will need to log in to the Sonia account we've created for you, join the Fall 2024 Student Teaching placement group, and complete the Fall 2024 Application for Student Teaching <u>by 11:55 PM on Thursday</u>, February 15<sup>th</sup>.

# To log in to your Sonia account:

- 1) To open Sonia, go to https://fhsu-coe.sonialive.com
- 2) Bookmark the Sonia website (you'll return to it often)
- 3) In the top left corner of the screen, check to make sure your Role shows as "Student"
- 4) Click the "University Sign In" button
- 5) Enter your FHSU Tiger ID and password information

### To find the application:

On your "Home" tab, you'll see two live links. The linked information will explain how to add yourself to a placement group, complete an application, update your profile, and complete checks.

### Tips:

- Once you add yourself to the placement group, the application will be issued to your account.
- Use the "Placements" tab to add yourself to the placement group.
- Use the "Forms" tab to find the application
- ➤ Use the "Checks" tab to upload verifications or check to see if the verifications you've previously uploaded need to be updated.

## **OTHER NOTABLE INFORMATION:**

- ➤ Required Courses You should still submit your Fall 2024 Application for Student Teaching even if you'll be finishing up required courses during the spring 2024 semester or summer 2024 term. As long as you've met all other necessary requirements, your application will be reviewed and we will begin coordinating your placement. You will not be officially approved for fall student teaching until we can verify that ALL requirements, checks, and forms are complete.
- ➤ TB Test Verification, National Background Check Verification, and Professional Liability Insurance Verification Following submission of your Fall 2024 Application for Student Teaching, you will need to review the information included in the "Checks" portion of your Sonia account. This is where you'll either upload the necessary required verifications or confirm that the verifications you previously uploaded will be valid throughout your field experience semester. The information included in the "Checks" tab will tell you if each required check is complete or incomplete.
  - Plan ahead and make sure to have these verifications loaded to your computer before starting your application.
