

Acknowledgement of Certification and Agreement:

Fort Hays State University (FHSU), on April 23 signed and returned the first half of the Funding Certification and Agreement to the Department of Education. On April 24, FHSU signed and returned the second half of the Funding Certification to the Department of Education. FHSU has allocated 50% of these funds under Section 18004(a)(1) of the CARES Act to provide Emergency Financial Aid Grants to their students for costs due to the coronavirus and disruption of on-campus operations. FHSU acknowledges and intends to solely use to the funds for the purposes that have been authorized in Section 18004(a)(1) in the CARES Act.

On May 5, 2020, FHSU signed and returned the Certification and Agreement to the Department of Education for the additional CARES Act HEERF Strengthening Institutions application for an additional \$124,525. These funds will be awarded and disbursed to students from the original pool of applicants. All of the eligibility criteria will remain the same. Any unused portion of these funds will then go to the institutional share to use for appropriate campus operations and expenses.

On December 27, 2020 the Coronavirus Response and Relief Supplemental Appropriations Act, 2021 (CRRSAA) (HEERF II) was passed. Fort Hays State University received an allocation and intends to provide at least the same amount of funding in financial aid grants to students as was required to provide under sections 18004(a)(1) and (c) of division B of the Coronavirus Aid, Relief, and Economic Security Act (CARES Act)(Pub. L. 116-136). Institutions must make financial aid grants to students which may be used for any component of the student's cost of attendance or for emergency costs that arise due to coronavirus, such as tuition, food, housing, health care, or child care.

On March 11, 2021, the American Rescue Plan Act, passed and provided funds for the Higher Education Emergency Relief Fund III (HEERF III) grant. This is the third round of funding appropriated to institutions to provide emergency grants to students for prevention, preparation, and response to coronavirus. Fort Hays State University's plan includes distribution to students who were enrolled in at least one credit hour at FHSU on or after March 13, 2020 and who can demonstrate exceptional need.

Total Funds Received:

Fort Hays State University has received \$2,524,076 under section 18004(a)(1) of the CARES Act from the Higher Education Emergency Relief Fund. Of these funds, \$1,262,038 (50%) has been allocated to students as financial grants.

FHSU has also received \$124,281 for the Higher Education Emergency Relief Strengthening Institutions fund. An additional \$1,455 was added on October 29, 2020 making a total of \$125,736. On March 4, 2021 an additional \$235,817 was awarded bringing the total Strengthening Institutions funds to \$361,553.

On December 27, 2020, FHSU was awarded \$6,157,168 in HEERF II funds. Of these, 1,370,261 was to be awarded as student grants.

On March 11, 2021 FHSU was awarded \$18,226,383 in HEERF III funds. Of these, \$9,685,909 was to be awarded as student grants

On August 3, 2021 FHSU was awarded an additional \$790,128 in FHSU CARES Act HEERF – Strengthening Institutions Program funds.

Eligible Students:

Fort Hays State University has determined that approximately 2,948 students are eligible under Section 484 in the Title IV of the Higher Education Act of 1965. These students are eligible to receive Emergency Financial Aid Grants under Section 18004(a)(1) of the CARES Act. Among these students who meet the criteria, their financial need is taken into account to determine if they will receive a block grant or must apply for the funding. The eligible students are divided into those that are PELL eligible and other Title IV students who are not PELL eligible. The \$1,262,038 will be divided among these eligible students based on need and expenses accrued due to coronavirus.

The additional \$124,525 will be made available for students who are TIV eligible and who applied for the grants.

Distributing Method

HEERF I: We recognize that students who were PELL Eligible at the time campus operations ceased on-campus instruction, were impacted greatly since they have the most need. A variety of disruptions occurred, as students were asked to move on short notice, and have incurred extra travel, internet service, and/or other costs associated with the changes and disruptions. For example, many students were also no longer able to utilize the food services at FHSU and would have been required to pay for food for the last six weeks of the academic year. These students would need to have a way to access classes at home and could have been required to purchase a computer or other technology. Due to these factors, and in alignment with the Department of Education's guidance and original allocation formula, PELL students were determined to have been significantly impacted, and the awarding process outlined herein developed.

FHSU awarded and distributed the HEERF student grants with a hybrid approach. Pell eligible students received a block grant and all other eligible students must apply for the funds. The student allocation of \$1,262,038 was split 75% for PELL eligible students and 25% for all other Title IV eligible students who completed a FAFSA prior to the end of the Spring 2020 semester. Students had to be enrolled in at least one on-campus class at the time of the transition of campus operations and have to be Title IV eligible to qualify for the funds.

An online form has been created. Students who are not PELL eligible can select items (listed below) that they had to pay for or purchase due to the conversion to online instruction and their move from campus. When the completed application is returned FHSU will assign one of four possible awards (\$100, \$300, \$649, \$803) based on the students need, the costs reported, and the number of applications received. Applicants will be considered on a first-come first-serve process, and when funds are depleted the program will then end. The components are as follows:

Other:

Rent was not included in the list as students who were living on campus were given a prorated refund of housing. These funds could have been used to pay for housing they needed to secure when moving off campus. If they lived off campus at the time of the transition to online, this cost was not a new cost incurred by the student.

Upon disbursement, eligibility will be reviewed again for any students who dropped all classes for the semester at 100% refund. They would not be eligible for the direct grants.

HEERF I Supplemental: The remaining applications from students who were not Pell eligible were used to award a portion of the Strengthening Institutions funds. When all applications were evaluated and awards had been made, the remaining funds were used by the University to pay for expenses incurred by the disruption to campus operations in compliance with Section 18004(a)(1), 18004(c) and 18006 of the CARES Act. \$124,057

HEERF II Supplemental: FHSU added the institutional money back into the pool for awarding in HEERF II. All students awarded had an EFC less than or equal to \$5,711. \$197,000 was awarded to students during the HEERF II awarding cycle.

HEERF III Supplemental Awarding: FHSU added the additional \$40,464 into the HEERF III awarding cycle and utilized the remainder of the funds.

HEERF II:

In accordance with the regulatory requirements set by the Department of Education, HEERF II funds were prioritized for student with exceptional need. Students had to be enrolled in at least one credit hour on or after March 22, 2021, be eligible to receive Title IV aid, have a FAFSA on file with Fort Hays State University, and have an expected family contribution less than or equal to \$5,711. If all requirements were met, students were awarded a direct grant of \$500.

The remaining \$761 was awarded in the HEERF III funding cycle.

HEERF III 1st Round:

The American Rescue Plan Act, passed March 11, 2021 provided funds for the Higher Education Emergency Relief Fund III (HEERF III) grant. This is the third round of funding appropriated to institutions to provide emergency grants to students for prevention, preparation, and response to coronavirus.

Eligibility Criteria:

- Must have been enrolled in at least one credit hour at FHSU on or after March 13, 2020;
- Must have exceptional need.
 - Exceptional need is defined as being Pell eligible or students with extraordinary financial circumstances.
- Must verify or update ACH data in TigerTracks. If check is selected, must have domestic mailing address (permanent address) in TigerTracks.

In accordance with Department of Education guidelines, FHSU will distribute HEERF III Grants in one of two ways:

- PELL eligible students will receive a direct grant. Pell eligibility will be determined by the expected family contribution calculated on the FAFSA that Fort Hays State University has on file.

In 2020-2021 students with an EFC of 5,711 could have been considered Pell eligible. EFC will be based on the year the student was or is enrolled. All Pell eligible students will receive a direct grant of \$1,000.

- All other eligible students are able to apply for the remaining HEERF III grant funds. Students in this group must meet all the eligibility requirements outlined above. Students in this group will be notified that they are eligible through their FHSU email. **Awarding to this group will be on a first-come, first-serve basis, and when funds are depleted awarding will cease.**

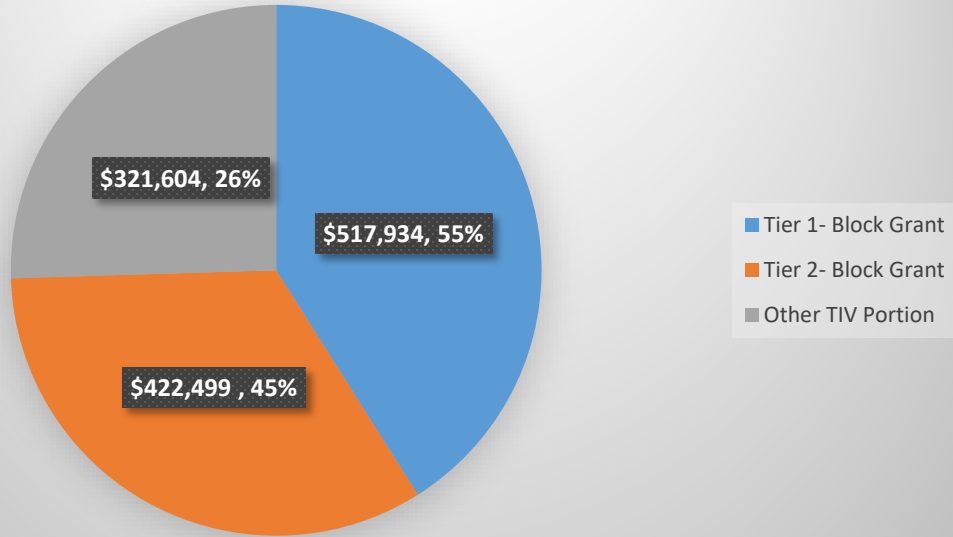
HEERF III 2nd Round:

- Must verify or update ACH data in Workday. If check is selected, must have domestic mailing address (permanent address) in Workday. In accordance with Department of Education guidelines,

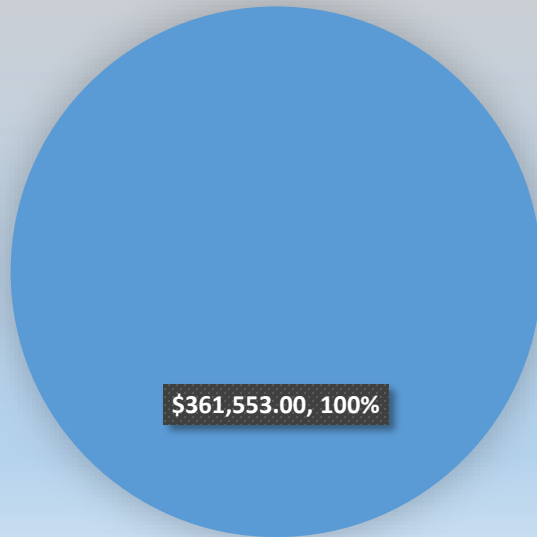
In accordance with Department of Education guidelines, FHSU will distribute HEERF III Grants in the following manner:

Students will be notified that they are eligible through their email that includes a link to the application. Awarding will be on a first-come, first-serve basis, and when funds are depleted awarding will cease.

Student HEERF Direct Grants - \$1,262,038



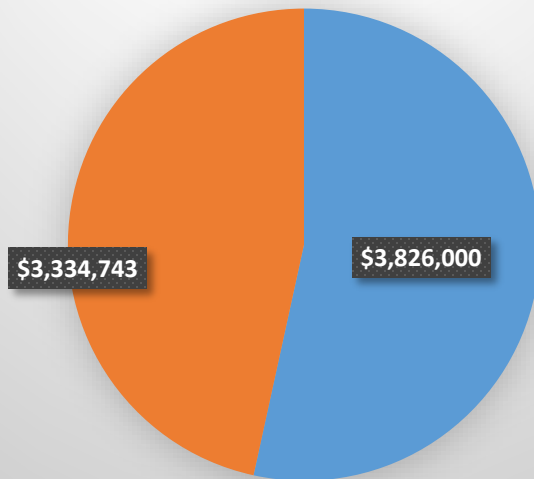
Strengthening Institutions Grants - \$361,553



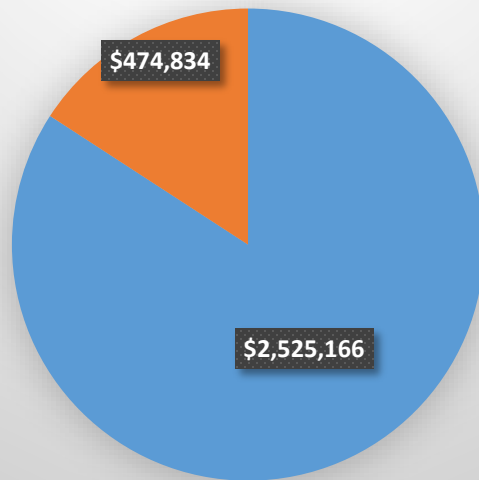
Student HEERF II Grants - \$1,370,261
