

## ***Kansas Insurance Certificate (12 hours)***

The Kansas Insurance Certificate provides academic preparation for students who want to pursue a career in the insurance industry. To obtain the Kansas Insurance Certificate, students must complete 12 hours as outlined below with no grade lower than a 'C':

FIN 630 Insurance Planning (formerly FIN 391 or FIN 631)

*Plus three of the following classes:*

FIN 401 Property Insurance

FIN 670 Estate Planning

FIN 680 Retirement and Employee Benefit Planning

MKT 302 Strategic Selling (PR: MKT 301)

FIN 467 Internship (Insurance related and approved by dept. chair)

FIN 450 Personal Financial Planning (with instructor approval)

The certificate classes are all available online – FIN 630, FIN 680, and MKT 302 in the fall; and FIN 401, FIN 450, and FIN 670 in the spring. FIN 467 can be taken in any semester with approval.

To request your official certificate for the Kansas Insurance Certificate program, please fill out the "Intent to Complete the Kansas Insurance Certificate" form and return it to the Department of Economics, Finance, and Accounting in MC 201 or send electronically to [lmkepka@fhsu.edu](mailto:lmkepka@fhsu.edu) during the semester you are completing your final class for the certificate. You should receive your certificate in the mail approximately 6-8 weeks after you complete all requirements.
