
Returning to campus after a hospital stay, extended illness, or family emergency is challenging.

RESIDENTIAL LIFE

Contact the Office of Residential Life should you need accommodations upon returning to campus. They can provide options such as a new rooming assignment to assist with accessibility.

If you need family or friends to retrieve items from your residence hall room, you are required to complete a waiver form. Residential Life must have a signed waiver before allowing a family member or friend to remove items from your room. You or the designated person must contact Residential Life to obtain a waiver form and schedule a time to retrieve items from the space. PROFESSOR NOTIFICATIONS WHAT IF I MISS CLASS?

If you will be absent from class due to a medical reason or family emergency, you can request a professor notification be sent from the Office of Student Affairs. You must call to inform the Student Affairs Office of the reason for the absence and time-frame for return, if known. It is your responsibility to contact each professor to discuss missed classes and assignments. If you miss several days of classes, the Student Affairs Office will request documentation supporting your absence. Documentation can be delivered electronically or in person to the Student Affairs Office, 208 Sheridan Hall.

MEDICAL WITHDRAWAL

Students may initiate withdrawal from the University for medical or psychological reasons or due to a family emergency (for self or immediate family). To request a withdrawal, The Medical Appeal Form must be submitted to the Office of Student Affairs. All instructions are included on the form.

The Medical Appeals Form is used to request a waiver of University Policy. Medical appeals to withdraw late or obtain a tuition refund may be granted only for severe, extenuating circumstances such as hospitalization, psychological reasons, a death in the immediate family, etc. Modifications to housing contracts may also be possible. If a student is a Title IV recipient, their account will be reviewed for return of Title IV funds.

Medical appeals for a late withdrawal must be submitted within one term of enrollment in the class(es) for which the student is appealing. Documentation much be included with the appeal and must show how the extenuating circumstance prevented withdrawal by the deadline date.
